Public Participation

Planning agent- introduced herself to the members of public. Advised the layout has changed, to include public open space and they have kept the willow trees.

Speed table- advised this maybe damaged by the lorries involved in the development if installed prior to any work taking place.

Resident- disappointed by the response from the developer that they have only reduced the houses by one. They feel this does not really indicate the agent is listening to residents.

Speed table- concerns about the noise/ vibration of empty lorries driving over the speed tables.

Resident- speed table- it may reduce help the development but does not stop the speeding and amount of traffic travelling along Main Street.

Resident- asked about the general planning process.

22/02490/FUL- Demolition of all buildings and erection of 18 dwellings and construction of accesses to highway, Adjacent 9 Cross Street Farcet.

Planning (Please note: in planning matters the Council acts as the consultee of the Principal Authority.

The following points were raised by the Parish Council:

No improvement to the drainage situation. The Parish Council were provided recent pictures of the surface water after recent storms, which solidifies the concerns regarding drainage.

No agreement on the foul water.

Still too many houses of the site-scale and dominance to much for the site.

There were questions raised regarding some of the data used, such as how they can justify only 2 children using the school given the number of houses on the site.

Still too many houses with access via Cross Street.

Safety audit conducted on a Wednesday between 12:30-1:15- not an accurate use of the village.

This is the quietest time of the day for traffic in the village based on the data obtained via the Parish Council MVAS unit.

Other comments made, that were not material planning considerations, however concerns regarding the developers Construction management plan

Concerns over the dust being created as no mention of how to prevent from occurring.

Roadways- suggested wheel wash and cleaning up at end of the day. Should be cleaned at the time of any mess created, rather than the end of the day as any debris is a hazard.

Deliveries- Via King's Delph Drove, definition of construction and deliveries? How will they quarantee this will happen?

No smoking on Street- so where will the workers smoke. Will there be cigarette ends by left around the village.

Resolved: It was proposed by Cllr Gillam, seconded by Granger and unanimously agreed to recommend refusal based on the concerns raised above.

PR0960 Proposed Raised Junction Table - Main Street, Farcet

This will only go ahead if planning permission is granted on 22/02490/FUL.

This is not going to address speeding and amount of traffic further along Main Street, but may help the development.

Suggest that this is installed prior to any potential work taken place.

Resolved: It was proposed by Cllr Hughes, seconded by Granger and agreed to support the scheme if planning permission is granted. It was also agreed that we request the is installed prior to the start of any development.
